ATTACHMENT A - ELECTION TO THE BOARD OF DIRECTORS

In accordance with Section 13 of the AWF Constitution, at the 2025 AGM two Director shall be elected.

Nomination for the election of a Director position must be submitted to the Chief Executive Officer prior to midnight AEDT on **Tuesday 18 November 2025** and be ratified by the authorised representative of a State Member, or an AWF Director.

Nomination for the Director position must be:

- In writing and on the prescribed form;
- Signed by the authorised representative of a State Member or an AWF Director; and
- Certified by the nominee expressing their willingness to accept the position for which they are nominated.

A Nominee for a Director position on the AWF Board must declare any position they hold in a State Association, including as an Office Bearer, paid appointee or employee. If the nominee is elected, he/she must resign from their position in the State Association, including but not limited to a position as Officer, Director, paid employee or appointee. Voting shall be conducted in accordance with Section 13 of the AWF Constitution and should there be more than two nominees, through an Exhaustive Ballot, the procedure for which will be provided prior to the election.

Individuals considering nomination will have to commit to attending a minimum of five (5) meetings/workshops per year which may take place at weekends, weeknights or weekdays.
